This agreement is between (Christopher Jorde, DBA as Heart J Outfitters) and _____ (Client), entered on ____ day of _____ (Month), _____ (Year). From this point on, all parties will be referred to as Heart J Outfitters or Client.

HUNTS—All hunts are 7-days and usually run Saturday-Friday unless specified or other arrangements have been made. Arrival is Saturday morning and departures are the following Saturday morning (unless specified differently).

TRANSPORTATION—All transportation to and from the Minot International Airport, to and from hunting locations, licensing agent, and processor are included.

BLINDS/STANDS, FEED, & TRAIL CAMERAS—Blinds/stands will be set as well as feed and trail cameras to make your hunt as successful as possible. Trail camera photos will be sent monthly exclusively to clients of Heart J Outfitters. All stands are set up with bow hangers, lifelines, and haul lines.

LODGING/MEALS—All lodging and meals provided with clean, comfortable accommodations. Lodging will be in our three-bedroom lodge with amenities included. Breakfast and supper will be provided, but may be prepared by client. Supper will be hot and be prepared by Heart J Outfitters. All snacks, as well as beverages, will be supplied by the client. Heart J Outfitters has a strict policy on a smoke-free lodge and alcohol only after hunting hours.

SCENT CONTROL—All field spray, shower shampoos, and soaps will be provided to allow travel ease for our clients. We also provide Ozonics machines to our clients to help with scent control.

SET-UPS—All set-ups will be in the 20 to 30 yard range and clients are expected to be comfortable shooting in that range. Set-ups are as follows: September consists of mostly treestands, late October to early November consist of treestands (weather permitting) and blinds, late November, December, and early January (depending on season dates) mainly blinds. Heated body suits are provided for all hunts if needed.

LICENSES—All applicable licenses will be purchased upon arrival from a North Dakota Game & Fish licensing agent. You will need a Nonresident Fishing, Hunting and Furbearer Certificate, General Game and Habitat License, Deer License (Whitetail). Surplus Fall Turkey tags may be available for purchase from North Dakota Game & Fish, as the number of available tags allows. All clients will have read their proclamation from North Dakota Game & Fish and have become familiar with, and follow, all North Dakota laws and regulations.

DOWNPAYMENTS FOR CURRENT YEAR OF HUNT—A 50% deposit will be sent with this agreement at the time of booking to hold hunting dates as well as protect against any future price increases. The remaining 50% will be due upon arrival to camp. This deposit is non-refundable.

DOWNPAYMENTS FOR FUTURE YEAR OF HUNT—A \$500.00 deposit will be sent with this agreement at the time of booking to hold hunting dates as well as to protect against any future price increases. The remaining \$750.00 will be due by May 1st of the year that the client will be coming to hunt. The remaining 50% will be due upon arrival to hunt. This deposit is non-refundable.

MEDICAL CONDITIONS OR DISABILITY—All conditions and disabilities will be, and must be, made known to Heart J Outfitters in case of emergency.

ALCOHOL AND TOBACCO USE—Alcohol may be consumed at Heart J Outfitters but only at the lodge *after* hunting hours. Tobacco use is prohibited in the lodge or in the field at all times. Smoking is allowed but only outside of the lodge. Our alcohol and tobacco use policy is considered a *zero tolerance* policy.

WOUNDED ANIMALS—When blood is drawn, the animal is considered harvested by the hunter—regardless of recovery. This policy may change with the discretion of Heart J Outfitters and if other arrangements have been made.
